- 1. I will assure that all players on my team have been registered with the GSF for insurance purposes.
- 2. I understand that the GSF is organized to promote youth athletics and good sportsmanship.
- I understand that my conduct while coaching will have a definite impact on the youth for whom it is intended, the program, and myself.
- 4. I pledge to support, cooperate, and work in every way to promote youth athletics in the best interest of the programs and the youths involved.
- 5. I pledge to be respectful to all officials, even in an expression of disagreement.
- 6. I understand that each team is governed by the GSF and the parents of the players. My tenure as coach is dependent upon their approval and consent of my conduct.
- I do agree to adhere to the principles of good sportsmanship and to the rules and regulations defined by the GSP.
- 8. I understand that if any individual (players, coaches, officials, or spectators) displaying unsportsmanlike conduct whether during or following game will be subject to partial or permanent program suspension. Unsportsmanlike conduct is defined as, but not limited to the following:
  - a. Harassment of participants or officials, or
  - b. Use of profane language and/or gestures, or
  - c. Public threat or physical violence.
- 9. Coach's and Adult's Ejection and Suspensions:
- a. I understand that if any adult, including a coach, is ejected or suspended from a game, he or she will be suspended from participating in the next game to be played by his or her team.
- b. I understand that if any adult, including a coach, is ejected or suspended from a second game during any one season, he or she will be suspended from participating in all the remaining regular season games and all the end of season tournament activities that his or her team may be involved in.
- c. I understand that if any adult, including a coach, is found under the influence of alcohol or drugs while at a GSF function, he or she will be suspended from participating in all pre-season activities, all regular season activities, and all end of season activities that his or her team may be involved in.
- d. I understand that the GSF Board will review all adult ejections or suspensions and may extend any suspension beyond what is stated in 9a above as deemed appropriate for the offense.
- 10. Player's Ejection and Suspensions:
- a. I understand that if any youth is ejected or suspended from a game, his or her actions will be reviewed by the appropriate athletic commission to determine if further disciplinary action is appropriate according to the severity of the offense.
- b. I understand that if any youth is ejected or suspended from any two games within one season, he or she will be suspended from participating in the next game to be played by his or her team. Furthermore, the youth may not return to his or her team until his or her parents/guardians have had a personal conference with the team's coach and the GSFR President.

Furthermore, the youth may not return to his or her team until his or her parents/guardians have had a personal conference with the team's coach and the appropriate athletic commission.

- c. I understand that if any youth is ejected or suspended from a game after having a conference as outlined in 10b above, he or she will be suspended from participating in all the remaining regular season games and all the end of season tournament play that his or her team may be involved in.
- d. I understand that the appropriate athletic commission will review all youth ejection and suspensions and may extend the suspension beyond what is stated in 10b and 10c above as deemed appropriate for the offense.
- 11. I understand that if I hold practices other than the ones scheduled (time and place designated by the GSF), the practices will not be made mandatory. Any coach having a mandatory practice other than the ones scheduled by the GSF or takes action against a player for missing an optional practice will be disciplined as outlined in item 9 above.
- 12. I understand there will be no out of town practice games allowed during the pre-season, regular season, and end of season tournament play. NOT APPLICABLE FOR TRAVEL TEAMS.

- 15. I agree that I will not purchase or request parents to purchase uniforms for practice or games. I agree to only allow my players to wear uniforms issued by the GSF.
